### Minutes of Meeting

1. The Committee was headed by Hon'ble Vice - Chancellor and other Committee members present were Ms. Neha Chauhan and Mr. Nitin Gupta from DIC, Solan, Dr. Ashish Kumar, Dr. Rajiv Kumar, Dr. Gunjan Goel. The VC welcomed all the committee members.
2. Discussion and progress update of total ten Incubatee application forms received through HPCED was discussed. Five Incubatees named Mr. Ajay Sharma, Mr. Anuj Sharma, Dr. Anil Singla, Mr. Bhanu Uday and Mr. Abhishek Singh were invited for discussion with screening committee.
3. Among the five incubatees, three incubates named Mr. Anuj Sharma, Dr. Anil Singla and Mr. Bhanu Uday joined for the meeting and two proposals were considered in Absentia.
4. The four incubatees were advised for improvement in their proposal with the help of mentors available from JUIT. They were advised to re-submit their Proposals on the basis of recommendations, within fifteen days.

6. Dr. Anil Kumar Singla, Mr. Kanwar Bhanu Uday Singh, Mr. Ajay Sharma, Mr. Anuj Sharma and Mr. Abhishek Singh are registered as Incubatees.
7. The Proposal of Mr. Anuj Sharma was found to be satisfactory with his prototype therefore; the committee recommended his case for sustenance allowance as per the CM Start-up Scheme.
